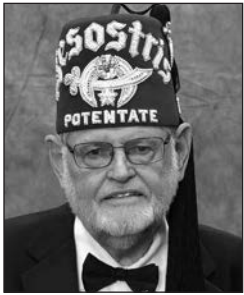

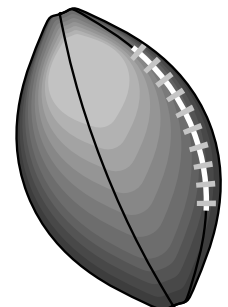
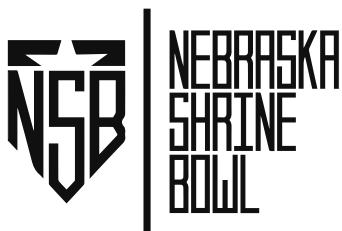

## Patient Financial Services Information

### Does Shriners take my insurance?

Shriners Healthcare for Children (SHC) accepts and bills for all insurance providers, including Medicare and Medicaid. You may contact your insurance provider to see if we are an in-network or out-of-network provider.



### What's the difference between an in-network and out-of-network provider?

If a doctor, clinic, hospital or health care facility you visit is part of your insurance company's network, you'll get your health care at lower prices. But if you go out of your network for health care, it can cost you more out of pocket.

### Will I have an out of pocket cost at Shriners?

SHC will send you a bill for the remaining balance after your insurance company has processed the claim.

Once you receive your bill from SHC, and if you feel the amount due will cause a financial hardship to you and your family, please contact the clinic and ask to speak to Patient Financial Services.

### Do I need a referral to be seen at Shriners?

If you have an insurance plan that requires you to obtain a referral to seek care from a specialist, please talk to your primary care provider prior to your appointment and request the referral to be sent to SHC. Referrals are required for Tricare, Medicaid and other Managed Care Organizations (MCO).

If you are unsure if a referral is needed, please contact your insurance providers' customer service number, typically found on the back of your insurance card.

### Do I need a prior authorization?

Authorizations regarding services provided and/or ordered by SHC will be handled by our patient financial services staff.

### What if my child does not have insurance?

At SHC, we do not turn away patients who do not have health insurance. We have many ways to assist those that would face difficult financial concerns. Our patient financial services staff will aide you in finding medical coverage and/or financial assistance. We also offer charity and shrine assistance for those that do not qualify for private or state funded health benefits.

Please contact our patient financial services staff to discuss options that would work best for you and your family.

### What if my child is being seen at SHC due to an injury?

If your child's visit to SHC is due to an injury, please provide us with the date and time the incident occurred when you check in for your appointment. It also helps if you have the names, dates and locations of any health care professionals that have already treated your child for this injury.

If the injury is being covered by another individual's health insurance, auto insurance or other type of medical coverage, please bring any documentation you have regarding this policy including the policy holder's name and policy identification number.

### Services performed outside of Shriners Healthcare for Children

There are times a patient will need services performed that cannot be completed at SHC. This will include all surgeries, MRIs, CT, gait labs, etc. It is important to know if the location of these services are within your insurance network. If they are not, please notify us and our patient financial services staff will work with your insurance company to get these services pre-approved.

If financial assistance is needed in order to receive these outside services, please contact that facility's financial services staff to apply for assistance. If denied financial assistance from the outside services facility, contact SHC with the denial information, and we will help you with other options.

### Surgery

All surgeries will take place through an outside facility such as Gillette Children's Specialty Healthcare, University of Minnesota or Mayo Clinic. It is important for you to know if the surgery locations are within your insurance network. If the location is not in network, you should inform your physician. The outside facility will attempt to prior authorize the surgery with your insurance.

If financial assistance is needed in order to receive surgery at the outside facility, please contact the chosen facility and apply for financial aid. If denied financial assistance from the outside facility, SHC will explore other options that are available.

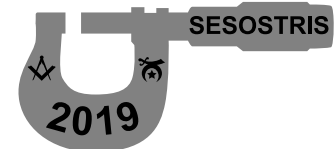

## Special Potentate Pin/Tie Tack

When I ordered my Potentate's pins, I had a special pin designed and a limited supply ordered. This pin is a small scale design of a tool used in my profession as a tool maker. This tool is called a “micrometer”. It is a very accurate measuring device measuring to .0001 “one ten thousands” of an inch. — That's taking a human hair, which measures approximately .003 of an inch in  $\varnothing$ , and splitting that hair  $\varnothing$  30 times.

My goal of ordering this pin/tie tack was for a small fundraiser to help fund a new project called the Legacy Wall. I offer this pin/tie tack for a suggested donation of \$3.00 to be used totally for funding the Legacy Wall. See me if you are interested.

# SESOSTRIS GUN CLUB

As the temperatures warm, so do the activities of the Sesostris Gun Club. Our friends at Nebraska Shooters open their ranges to the public for "Fun Fridays." Starting at the end of May, shooters are welcome to come out to the range for some trigger time. The range safety officers will help set up for shooting paper, clays or even the Texas star. We have even set up for a bowling pin competition. Fun Fridays are free. Nebraska Shooters just asks that shooters pre-register on its website prior to Friday. This helps insure there are enough safety officers on hand to assist all shooters.

The Gun Club also enjoys a little competition. Their pistol shooters enjoy an event called "Rock Your Glock." This is a pistol shoot held at the outdoor range at DE guns. It is open to all makes of pistols as well as Glocks. The registration is \$10 for your first gun and \$5 for the second if you choose to shoot more than one. The course has three shooting stations and is a timed event. Your shooting is scored. This makes it fun to see how you compare to your fellow shooters as well as seeing your improvement from month to month. You will need about 120 rounds of ammunition for the day.

Our more serious pistol shooters travel to matches of the Glock Sport Shooting Foundation. One must be a member to shoot in GSSF and shooting a Glock is required. The closest GSSF matches are in Grand Island, Nebraska;

Sioux Falls, South Dakota; Wellington Kansas; Hallsville, Missouri; and Louisville, Nebraska. The GSSF awards many prizes at each shoot. Many of our members have won new Glock pistols at these events.

If the shotgun is more your sport, the Gun Club forms a team for both the summer and fall trap leagues at Izaak Walton. The summer league runs 12 weeks and starts the second Thursday of May. The fall league runs August to October. The Gun Club takes care of the team registration. It only costs each shooter \$7/round of competition. We are always looking for new shooters.

If you have interest or questions, come check us out. The Gun Club meets the last Monday of the month.

organization liable for penalties. However, all temple returns must be filed on IRS Form 990 regardless of whether they have \$50,000 in gross receipts or not (see COMPLIANCE WITH INTERNAL REVENUE CODE herein).

(b) Effective for returns to be filed for calendar 2011, or for fiscal years ending January 31, 2012 or later, all fraternal organizations required to file Form 990 (i.e., gross receipts over \$50,000) must make available for inspection, at their principal place of business, during regular business hours, a copy of each annual information return filed by the organization for a period of three years from the date it is required to be filed (including extensions). This means that if a fraternal organization files its Form 990 on a calendar year basis (and assuming no extension is granted by the IRS) then as of May 15, 2012, it must have a copy of the entire 2011 return available for inspection by any individual who asks to see it.

(c) If the fraternal organization regularly maintains one or more district or regional offices which have three or more employees, a copy of the annual information return must be made available at each such district or regional office as well as the principal office.

(d) The fraternal organization must make available a copy of any papers it submitted in connection with its original exemption application. This applies to any organization filing a new application (IRS Form 1024) after July 15, 1987 and to all organizations which in fact have copies of their original exemption application. If an organization filed its application before July 15, 1987, it is required to make available a copy of its application only if it had a copy of the application on July 15, 1987. Subordinate organizations that did not file their own application for exemption must acquire a copy of the documents that were submitted to the IRS from the parent organization and make them available to anyone requesting such.

(e) A fraternal organization which is under duty to comply with the requirements of the legislation on public inspection of its annual return, or of its exemption application which fails to comply with the rules, is liable for a \$20 a day penalty for each day in which the failure continues. The maximum penalty payable by the organization for failure to disclose its return or exemption application is \$10,000 per year.

(f) If the IRS makes a written demand on the fraternal organization that it has failed to make available to the public its Form 990 or exemption application, the individual manager or managers responsible for the failure (IRS selects responsible person) is personally liable for a \$20 a day penalty for each day in which failure to disclose continues. The maximum penalty is \$10,000 on all persons for failure to comply, with respect to any one return.

(g) No penalty is imposed with respect to a failure if it is shown that the failure is due to reasonable cause. Ignorance of the law is not reasonable cause.

(h) In addition, the Internal Revenue Service is authorized to assess a penalty of \$5,000 on any person who willfully fails to disclose the information return or the exemption application.

(i) A person who willfully refuses to disclose the return or exemption application (or discloses false information) may also be prosecuted for his or her failure under Section 7207 as a misdemeanor (dealing with the prosecution of individuals for furnishing fraudulent information to the Internal Revenue Service).

### 3. GUIDANCE

§10701 of the Omnibus Budget Reconciliation Act of 1987 added new sections, §6113 and §6710 to the Internal Revenue Code, Section 6113 requires certain tax exempt organizations (such as our temples, units and clubs) that are ineligible to receive tax deductible charitable contributions to disclose in "an express statement (in a conspicuous and easily recognizable format)," the non-deductibility of contributions during fundraising solicitations. Section 6710 provides penalties for failure to comply with §6113.

(a) **FORMAT OF DISCLOSURE STATEMENT—SAFE HARBOR.** For purposes of §6113, a fundraising solicitation will be considered to include "an express statement (in a conspicuous and easily recognizable format) that contributions of gifts to such organizations are not deductible as charitable contributions for federal income tax purposes" if it satisfied the following requirements:

- (1) **PRINT MEDIUM.** In the case of solicitation by mail, leaflet, or advertisement in a newspaper, magazine or other print medium, the following four requirements are met:
- (i) The solicitation includes whichever of the following statements the organization deems appropriate: "Contributions or gifts to (name of organization) are not deductible as charitable contributions for federal income tax purposes," "Contributions or gifts to (name of organization) are not tax deductible," or "Contributions or gifts to (name of organization) are not tax deductible as charitable contributions,"
  - (ii) The statement is in at least the same size type as the primary message stated in the body of the letter, leaflet or ad;
  - (iii) The statement is included on the message side of any card or tear off section that the contributor returns with the contribution; and
  - (iv) The statement is either the first sentence in a paragraph or itself constitutes a paragraph.
- (2) **TELEPHONE.** In the case of a solicitation by telephone the following three requirements are met:
- (i) The solicitation includes whichever of the following statements the organization deems appropriate: "Contributions or gifts to (name of organization) are not deductible as charitable contributions for federal income tax purposes," "Contributions or gifts to (name of organization) are not tax deductible," or "Contributions or gifts to (name of organization) are not tax deductible as charitable contributions,"
  - (ii) The statement is made in close proximity to the request for contributions, during the same telephone call, by the telephone solicitor, and
  - (iii) Any written confirmation or billing sent to a person pledging to contribute during the telephone solicitation complies with the requirements under section (1) (Print Medium). Thus, for instance, any billing made to a contributor for advertising in a circus publication or for circus tickets must contain a statement on the invoice that:
  - (iv) "Contributions to (name of organization) are not tax deductible as charitable contributions."
- (3) **TELEVISION.** In the case of a solicitation by television the following two requirements are met:
- (i) The solicitation includes whichever of the following statements the organization deems appropriate: "Contributions or gifts to (name of organization) are not deductible as charitable contributions for federal income tax purposes," "Contributions or gifts to (name of organization) are not tax deductible," or "Contributions or gifts to (name of organization) are not tax deductible as charitable contributions,"
  - (ii) If the statement is spoken, it is in close proximity to the request for contributions; if the statement appears on the television screen, it is in large easily readable type appearing on the screen for at least five seconds.
- (4) **RADIO.** In the case of a solicitation by radio the following two requirements are met:
- (i) The solicitation includes whichever of the following statements the organization deems appropriate: "Contributions or gifts to (name of organization) are not deductible as charitable contributions for federal income tax purposes," "Contributions or gifts to (name of organization) are not tax deductible," or "Contributions or gifts to (name of organization) are not tax deductible as charitable contributions,"
  - (ii) The statement is made in close proximity to the request for contributions during the same radio solicitation announcement.

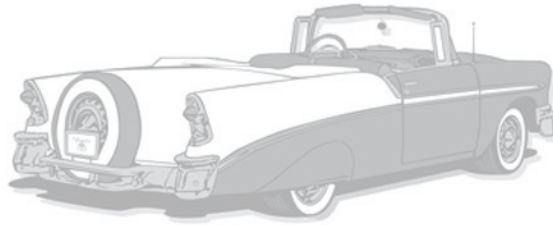
## - SESOSTRIS CRUIS'N CLASSICS -

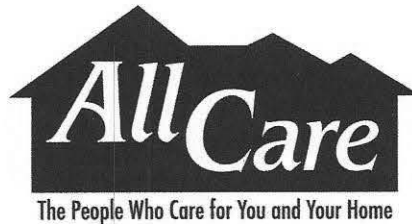

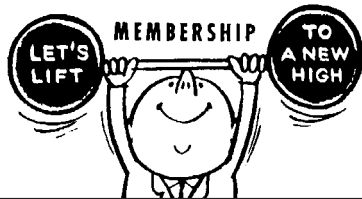
